It was learned that the contact "Chris" and [REDACTED] engaged in a text message conversation on November 1, 2016 at approximately 8:25 pm. Throughout most of the text message thread, Clark was angry that [REDACTED] was not coming to her residence. [REDACTED] and Clark texted back and forth, Clark appeared agitated with [REDACTED]. In the text message thread, Clark accused [REDACTED] of cheating on her with another woman. Clark accused [REDACTED] of being with another woman as this text message thread progressed. The text messages from Clark to [REDACTED] turn to animus and threats against the children. She was advised the messages included messages stating that she had killed her son and some video messages showed her sons lifeless body. The following are a sampling of the messages that Ms. Clark exchanged with [REDACTED].

9:00 pm (to [REDACTED] from Clark): By the way while you're having fun I guess I'll clean up toilet water from all over my house because YOUR kids thinks it's funny to fuck with me.

9:01 pm (to [REDACTED] from Clark): And I dare you to leave them here with me full time when you decide to move the fuck out 100%. I'm not about to lose my mind over something you wanted that you don't want anymore.

9:05 pm (to [REDACTED] from Clark): Stop fucking texting me you're gross you're disgusting as fuck you have no morals or standards and I always have to clwan up some did shit ya kids did for attention because they dad can't ever make up his fucking mind you kill me with the bullshit.

9:05 pm (to [REDACTED] from Clark): Ima Kill them watch

9:09 pm (to [REDACTED] from Clark): I'm done talking to because I have to scrub pissy smelling toilet water off my floor on my hands and fucking knees then I have to beat your kids ass and try to get them to go to sleep then I have to try to not lose my mind over a nigga that never gave a fuck about me All because you can't tell the fucking truth and you still want to use me in the fucking process.

*It should be noted that during an interview, Clark stated that one of the children took a block, filled it with toilet water, and poured it on the floor.

9:19 pm (to [REDACTED] from Clark): I don't want these kids here

9:19 pm (to [REDACTED] from Clark): Ya kids aint safe here i don't want them here

9:24 pm (to [REDACTED] from Clark): Answer me or im going to jail for child endangerment

*It should be noted that Clark was also pressing [REDACTED] about why he was not coming to her residence, the reason he provided why he was not coming, and why he did not tell her earlier that he was not coming to her residence.

9:24 pm (to [REDACTED] from Clark): Not dumb so either you can't sleep at her house or she has a car but I'm not stupid answer my fucking question before your daughter has a black eye and I go to jail

9:48 pm (to [REDACTED] from Clark): You were never coming here you right with a bitch

9:48 pm (to [REDACTED] from Clark): & ima keep doing wtf im doing util you decide to be honest about the fact that you were never coming here

9:48 pm (to [REDACTED] from Clark): So you better pray for your kids

9:56 pm (to Clark from [REDACTED]): Alright I'm not coming there leave them alone

10:01 pm (to [REDACTED] from Clark): Im killing them (ended with a laughing emoji with tears in its eyes)

10:02 pm (to [REDACTED] from Clark): FUCK YA KIDS SINCE THE PUSSY IS THAT IMPORTANT

10:06 PM (To Clark from [REDACTED]): I'll get of the last bus for you okay

10:14 pm (to [REDACTED] from Clark): VIDEO The video starts by depicting a young female child lying face down in a bed and pans over to a young male lying face down. Clark can be heard saying "Ahh look Angel is still alive and sweating your son on the other hand is not even breathing, I wish I could keep the camera still"

10:14 pm (to [REDACTED] from Clark): Send it to the cops post it to fb idc anymore you ruined my life

10:17 pm (to [REDACTED] from Clark): Fuck ya kids bitch

10:18 pm (to [REDACTED] from Clark): & I wasn't even gonna send you videos but pretty sure ya son is legit dead so fuck it im going to jail either way hope it was worth it

10:19 pm (to [REDACTED] from Clark): VIDEO The video starts by depicting Clark grabbing the female child's head. The female child cries. Clark next grabbed the male child's head, there was no reaction. Both children are face down in a bed. Clark can be heard saying "First of all she is clearly fine, because watch, see she is not dead. Him on the other hand, he doesn't budge. So you might want to call the ambulance".

10:20 pm (to [REDACTED] from Clark): Okay don't say I didnt warn you

10:20 pm (to [REDACTED] from Clark): All cus you wanted to go fuck her & come here when you felt like kt

10:20 pm (to [REDACTED] from Clark): YOU WERE NEVER COMING HERE NOW YOU GOT A DEAD KID

10:20 pm (to [REDACTED] from Clark): I STG ON MY DEAD CHILD HE AINT BREATHING IM OVER LYING TO YOU TO GET ATTENTION

10:20 pm (to [REDACTED] from Clark): YOU DON'T LOVE ME YOU NEVER DID YOU RUINED ME & LEY ME RUIN MYSELF SO IMA TAKE WHAT YOU LOVE

While reviewing the messages with Ms. Clark she admitted that she had pressed her sons face into the bedding of the air-mattress located in the living room. She stated that she did this for approximately one minute. She also stated that she was responsible for her son's death.
