**WAIVER OF EXTRADITION**

I, MATTHEW ISAIAH DARBY, DO HEREBY CERTIFY THAT I AM NOW UNDER ARREST, HAVING BEEN ARRESTED IN MYRTLE BEACH COUNTY, SOUTH CAROLINA AND STAND CHARGED WITH THE COMMISSION OF A CRIME, TO WIT CRIMINAL HOMICIDE, BURGLARY, POSS INSTR OF CRIME, THEFT BY UNLAWFUL TAKING, FLIGHT TO AVOID APPREHESION IN THE STATE OF PENNSYLVANIA.

I DO FURTHER CERTIFY THAT I WAS ON THE 11<sup>th</sup> DAY OF Oct. BROUGHT BEFORE JUDGE GLENN OHANESIAN OF THE MYRTLE BEACH MUNICIPAL COURT. THE SAID JUDGE DID FULLY EXPLAIN TO ME MY RIGHTS, AS REQUIRED BY THE STATUTES OF THE STATE OF SOUTH CAROLINA, MADE AND PROVIDED. THEREFORE, WITH FULL KNOWLEDGE OF MY RIGHTS, I DO HEREBY WAIVE THE ISSUANCE AND SERVICE OF A WARRANT OF EXTRADITION, AND DO HEREBY WAIVE ALL OTHER PROCEDURES INCIDENTAL TO EXTRADITION PROCEEDINGS, AND DO HEREBY VOLUNTARILY CONSENT TO RETURN TO THE STATE OF PENNSYLVANIA AND SUBMIT MYSELF HERE AND NOW TO THE CUSTODY OF SUCH LEGAL AUTHORITY AS MAY BE, OR MAY HAVE BEEN DESIGNATED TO TRANSFER AND TRANSPORT ME FROM MYRTLE BEACH COUNTY, SOUTH CAROLINA TO THE JURISDICTION OF THE STATE OF PENNSYLVANIA TO FACE THE SAID CHARGES AGAINST ME IN THAT JURISDICTION.
