Pursuant to Section 708(b)(3)(iii), photos of classrooms within District buildings have been redacted. Disclosure of these photos creates a reasonable likelihood of endangering the personal security and/or the physical security of District buildings.

Also pursuant to Section 708(b)(6)(1)(A), email addresses of inspectors performing work for the inspection company have been redacted, as their email addresses are not published on the company's website.
